Welcome to ASE!

ASE's mission is to develop future leaders with a high level of specialized theoretical and practical social science knowledge, as well as a good understanding and familiarity of African history and culture.

ASE has a rich educational infrastructure to accommodate both lecturers and students. On our campus, we have built a unique intellectual community. We have 95 students from 15 countries, 19 faculty trained at international renowned universities. We have set up four research programs in the Economics of Infrastructure, Human Development, Political Economy and Finance. We also have established academic partnerships with ten universities and we are currently working on eight more. ASE's international academic partnerships enable us to provide students with global exposure in both professional training and working experience.

ASE is committed to fostering academic and professional growth. Scholars share either preliminary or final findings of ongoing research projects with members of ASE community every week as part of the Research Seminar Series. In addition, students' knowledge and skills of career related topics improve through a series of workshops and educational activities (Professional Development Seminar Series) that will prepare them to make informed career related decisions. Moreover, starting in 2015, the African School of Economics has established the Summer Institute for Economic Research (SIER). Sponsored by the Open Society Initiative for West Africa (OSIWA) the goal of the Summer Institute is to contribute to the establishment of networks of collaborative, multidisciplinary research and policy engagement involving African academics and policy makers. ASE students participate actively in this event by attending the training session and also by presenting their research projects, allowing them to learn about potential employment opportunities as well as Ph.D. placements all over the world. In 2016 ASE will launch a new initiative, targeting the private sector, which will consist on an annual student run business conference involving academics and business leaders across Africa working in Finance, Management and Marketing. This would provide job market and entrepreneurship opportunities for our students, particularly those enrolled in our MBA program. Actually, we are proud to announce that a team of MBA students from our school is among the winners at the Global entrepreneurship week Award organized by the US embassy in Benin in December 2015. The judges were impressed with their performance and complimented the students, which were chosen to compete along with thirteen other schools of business and management, on their presentations.

Our innovative work-study program allows students to apply for financial aid to cover tuition fees in exchange for a work contract. This program offers \$2000 annually towards the cost of tuition and fees in exchange for 12 hours per week of student employment. Students may work as an intern with one of ASE's administrative departments, a teaching assistant with the faculty, or participate as a research associate with one our three research institutes.

Overall, ASE is committed to train the next generation of African business leaders, academics and policy-makers. Our first cohort will graduate in July 2016, and a future full of opportunities awaits them. ASE's graduates have great analytical skills, are fluent in French and English, and through their ASE education have been exposed to business leaders and academics. In addition, ASE's renowned reputation improves their chances for placement in graduate programs, positions in international organizations, governments and private corporations. Some of our graduate students receive job offers before finishing the program, while others are considering pursuing a doctoral degree. We are proud to be part of their success, as we trust their contribution will lead us to a brighter future. We hope that you too will join us and be a part of this success. Deadline to accept or deny your offer of admissions by paying security deposit of 60.000 FCFA (non-refundable)

Statement of Motivation

In no more than 500 words (one page), please describe your reasons for applying to the program of your choice, drawing on relevant research or professional experience, as well as your career objectives.

CV or Résumé

Provide a CV or résumé that outlines your experiences and interests including: university education; employment history; community and/or extracurricular activities; recognitions or achievements; special skills; language abilities.

Two Letters of Recommendation

We ask that you provide two letters of recommendation, at least one from a university professor with whom you have worked or taken classes, and who can tell us more about you and your academic potential. Letters of recommendation must be sent directly to ASE by the reference. Letters must also be typed, on official letterhead and signed.

Official Transcripts

We ask for official transcripts covering all previous university coursework, including confirmation of an earned bachelor's degree or equivalent. A minimum 3.0 cumulative grade point average (or equivalent) is recommended. All official documents must be submitted in English or French. If you are admitted to ASE, you will need to submit official final transcripts and examination results before you are allowed to enroll.

English Language Test (Recommended)

Entering students must demonstrate sufficient fluency in English. If English is not your first language, we recommend that you submit the results of an official English language exam of your choice. The English language test requirement is waived if you studied in an all-English curriculum for at least two years, or if are applying from an English-speaking country. The most common language exams are: TOEFL, TOEIC and IELTS

Standardized Tests

Standardized tests, such as the GRE or GMAT, are highly encouraged but not required for admission to the African School of Economics.

TYPES OF INTERNAL FINANCIAL AID

Tuition grant: This award is based on both academic merit and demonstrated financial need. It covers up to 1.211.000 FCFA. To be considered for ASE tuition grant the applicant must apply for it and submit all the supportive documents. This aid is renewable if the student maintains a 2.5 cumulative GPA or higher.

Work Study Program offers 1.211.000 FCFA annually towards the cost of tuition and fees in exchange for 12 hours per week of student employment. Students may work as an intern with one of ASE's administrative departments, a teaching assistant with the faculty or participate as a research assistant or data analysis assistant with one of our three research institutes. Participation in the program is renewable if the student maintains a 2.5 cumulative GPA or higher.

Teaching Fellowship: offers up to 1.815.000 FCFA annually in exchange for a given amount of hours (depends on each case) of student employment as a lecturer. This fellowship is only offered to second year and above Ph.D. students.

ASE Graduate Programs Overview

The African School of Economics will launch three new graduate programs in the Academic Year 2016-17. In addition to our Master of Business Administration (MBA) and Master in Mathematics, Economics and Statistics (MMES), ASE will start offering a Master of Public Administration (MPA), a Master of Development Studies (MDS) and a Ph.D. in Economics in September 2016. These new programs are designed to meet the growing demand for qualified professionals working in management and administration related occupations, international development institutions and research centers. Our Master programs seek candidates with strong academic performance in prior university studies, proven creative and analytical aptitude and exceptional communication skills.

Starting this year, ASE will accept applications throughout the year and programs will start in January and in September to accommodate students who come from outside Benin and whose academic calendars differ from the Beninese. Thus, there is no deadline for submitting applications to ASE.
